NOTICE OF SETTLEMENT

You are receiving this postcard because you are included in the Settlement Class for the above lawsuit. It alleges that because of problems with Sprint's commissions system, Sprint did not pay all of the commissions due to former or current business channel employees. The parties reached a settlement of \$3,650,000.00, which has been preliminarily approved by the Court.
